ISP Certification Metrics



ISP Program Metrics

(Note: previously reported displayed in red)

- **Total Number of ISPs:** 347 **(299)**
 - ISPs who re-certified since June 2011 seminar: 58 **(38)**
 - ISPs who re-certified since January: 25 **(35)**
 - Number of ISPs who did not recertify: 51 **(38)**
 - Number since June 2011 seminar: 10
- **June 1, 2011 – June 1, 2012**
 - Number of candidates who passed the exam 1st time: 52 **(81)**
 - Number of candidates who passed the exam on retake: 8
 - Number of candidates who did not pass the exam: 20 **(25)**

- **Successful transition to Continuing Education Unit (CEUs)**
 - **Effective 1 Jan 2012**
 - **Implemented an incremental CEU award**
 - **Updated all documentation and forms to support CEU**
 - **Reviewed training agendas and programs from Chapters, other security agencies and formal training agencies for CEU award determination**
 - **Provided sample attendance certificates and business card style certificates**

Objectives & Accomplishments



- **Progressed toward ISP Accreditation**
 - Revised policy and procedures to meet ANSI standards
 - Performed “Cut Analysis” of ISP exam questions
 - 1st application submission in Dec 2011
 - 2nd application submission in Mar 2012
 - Audit for Accreditation is scheduled for Aug 2012

- **Review and update the ISP exam, as necessary**

Objectives & Accomplishments



- **Implemented the SAP Elective**
 - The Education & Training Committee included SAP elective as part of the Exam Prep Program (EPP)
 - First tested at the 2012 NCMS 2012 Annual Seminar (hardcopy version)
 - Online testing will be implemented in the fall of 2012

Objectives & Accomplishments



- **Received BOD approval and funding to implement online recertification and certification applications**
 - Requires programming updates – MMCo is working
 - A date for implementation is forthcoming
 - Should streamline the application process



2011 - 2012

Objectives & Accomplishments



- **Implemented ISP Surveillance to meet ANSI Standards**
 - Random selection of 5% of current ISPs
 - Validate that ISPs are upholding high standards of ISP Certification
 - Confirmed by DSS Review results or by supervisor for those not following under DSS purview



Potential Program Revisions



- **Evaluating whether to continue hardcopy exams at the NCMS Seminar or switch to online testing**
 - Essentially hardcopy exams would be an exception only and approved on a case-by-case situation as approved by the ISP Certification Committee



Exam Prep Program



- This voluntary program is related to, but separate from, the ISP Certification Program.
- It is an informal program, run by ISPs, that is designed as a method to assist candidates in preparation for the ISP Certification Examination.
- This program does not provide “answers” to the ISP examination questions. Rather, it provides a structured approach to studying, a platform for discussions that will assist the candidate in confirming the accuracy of their knowledge, and a refresher on test taking strategies.



2011 - 2012 Objectives



- **The ISP Accreditation Committee will continue to pursue obtaining accreditation of the ISP Certification Program**
- **Monitor the ISP web page for accuracy**
- **Provide guidance and clarifications on obtaining the ISP Certification and Recertification**



2011 - 2012 Objectives



- **Branding of the ISP Logo**
 - Have already posted the ISP logo on the website
 - Ensure that all ISP documentation has the ISP logo
 - Adds recognition to the ISP Program and those that hold the ISP Certification

The ISP Accreditation Committee will continue to pursue obtaining accreditation of the ISP Certification Program

Purpose for CEU Conversion



- To align NCMS' ISP recertification point system with the industry standard of CEUs.
- To align the recertification process to meet or exceed the ANSI Accreditation standard.
- To Support Strategic Goals
 - ◆ #2(a) Develop, maintain, and improve the ISP Certification Program, to include accreditation;
 - ◆ #2(b) Develop, maintain, and improve the Mentoring Program I
 - ◆ #6 Establish an Information Security (IS) Program that attracts and retains IS professionals to NCMS and addresses their unique needs

So, What's the CEU Equation?



- ANSI, NCMS' Accrediting Company has accredited ASIS' recertification programs at one hour of instruction = one CEU
- Recommend that NCMS follow this equation for it's simple record keeping; for example:
 - National seminar at 24 hours = 24 CEUs
 - CDSE Course rated for three hours = three CEUs
 - Eight hour actual training chapter seminar = eight CEUs
 - One hour chapter meeting with 50 minute training = one CEU
 - Committee/officer time: defined in the new criteria
 - Formal education: defined in the new criteria
- 60 CEUs in three-year recertification term

To Stretch is to Grow!



Other Changes to the Recertification Program



- + Added chapter level committee work and officers in addition to the chair**
- + Added credit for mentoring**
- + Added items focused in computer security**
- Reduced the minimum number of actual training hours for a chapter meeting to one hour (must be a minimum of 50 minutes)**

Re-evaluated the definition of business-related courses

Working to Simplify



2011 - 2012 CEU Activities



1. Formally implemented the CEU on 1 Jan 2012
2. Updated the ISP Certification handbook and other associated documentation to reflect CEU changes
3. Expanded the recertification committee
4. Began marketing efforts to advertise the CEU transition
 - Wrote articles for the *Bulletin*
 - Posted information on the ISP website
5. Created CEU Review Subcommittee

ISP Lifetime Certification



NCMS, Inc. will confer a Lifetime Certification designation upon an ISP who wishes to maintain his/her ISP certification when the individual meets the following criteria:

- **Has maintained ISP certification for at least 12 consecutive years.**
 - **For ISPs who retire within 12 years of the start of the ISP Certification Program, this requirement will be waived.**
 - **For ISPs who retire fewer than 12 years after attaining their certification, but have recertified at least twice, this requirement will be waived.**
- **Has fully retired from all employment in the security field, including employment as a consultant and part-time employment for which some form of remuneration is accepted or given.**
- **Has paid the recertification fee for the current term.**
- **Submits an application (being developed now) for Lifetime Certification and signs the agreement to notify NCMS, Inc. should he/she return to employment in the security field.**



ISP Lifetime Certification



Privileges and Responsibilities

- Will receive a new certificate that states “Lifetime ISP.”
- Will continue to be able to use the ISP certification letters after his/her name, but must add “(retired)” at the end of the ISP; e.g., John Doe, ISP (retired).
- Will continue to be subject to the ISP Code of Ethics.
- Will not be required to earn recertification credits or apply and pay for recertification.
- Must immediately notify NCMS, Inc. should he/she return to part- or full-time employment in the security field. Such a return will negate the lifetime certification designation.

Take Away Notes



- **The level of effort for recertification should be practical to obtain with or without company budgets**
- **One point [old @ six points] \neq one CEU [new @ 60 CEUs]**
- **Requires more detailed record keeping**
- **Quantifying recertification efforts**
- **You can achieve recertification without training budgets**
- **There is always much work to do and we can use your help!**
