



ANSI Accreditation Received


- 27 September 2013






Continuing Education Unit (CEUs)


- Reviewed 79 training agendas and programs from Chapters, other security agencies, formal training agencies and individuals for CEU award determination. Have reviewed over 200 agendas and programs since Jan 2012!
- Reviews accomplished within a one to two day timeframe






- Completed beta testing from 2013 exam database review and generation of new questions
 - 21 volunteers participated in the beta testing
- Assisted candidates to determine whether experience qualifications were met to take the exam
- ISP ® 10th Anniversary recognition
 - Designed a 10th Anniversary coin that will be presented to each current ISP_® during 2014
 - Developed the ISP® Pioneer presentation to honor those that were instrumental in the foundation of the ISP® beginnings
 - Gathered testimonials for Bulletin article and filler throughout the rest of year. All testimonials to be posted on website.





- Completed ISP_® Annual Surveillance to meet ANSI Standards
 - Random selection of a minimum of 5% of current ISPs_®
 - Used only to validate sustained effective Industrial Security performance and high standards of the ISP® Certification
 - Validation Option 1: Confirmed by DSS Vulnerability Assessment results
 - Redacted cover letter showing a minimum Satisfactory rating






- Completed ISP_® Surveillance (continued)
 - Validation Option 2: Manager or client does an affirmation of acceptable performance and standards per the ISP® Code of Ethics
 - Validation results are filed in ISP® recipient's file folder; no personal or company identification is released
 - Note: Currently working on a process for those selected in an unemployed status...more to come!






- Continued to monitor the ISP_® web page for accuracy and currency
- Continued to provide guidance and clarifications on obtaining the ISP_® Certification and Recertification
- Began working on an ISP® Buddy program to assist Chapters with establishing and maintaining an ISP® Committee





- Branding of the ISP_® Trademark
 - ISP_® is a registered trademark (public notice of NCMS' claim of ownership of the mark)
 - NCMS' exclusive right to use the trademark and ensure proper usage
 - Branding of the trademark: posted on the ISP_® website, ISP_® documentation, signature lines, etc.
 - Adds recognition to the ISP_® Program and those that hold the ISP_® Certification
- Ensure the ISP_® trademark is not improperly used





- Articles in the Bulletin on Certification,
 Recertification, CEUs, Fee Increases, Accreditation,
 and other related topics
- Added relevant Past Bulletin articles to the website
- Conducted a survey to solicit ISP® proctor volunteers
- Enhanced existing ISP® documentation and created new documents as needed to support ANSI requirements
- Began developing online system for examination and recertification applications. Expected operational date is summer 2014





- Advertised that sample representative exam questions are available upon request from National HQ. This helps the candidate get the feel of examination and helps them better prepare for the examination process.
- Sent survey to determine why recertification was not completed; major reasons was retirement and career changes. Will continue to determine why recertification not accomplished and encourage recertification.



CEU History




- Transition to CEU as of 1 Jan 2012
 - Aligned NCMS' ISP® recertification point system with the industry standard of CEUs
 - Aligned the recertification process to meet or exceed the ANSI Accreditation standard

Status

- Well established, minimal effort and very positive results



Ways to Obtain CEUs



- NCMS National Annual Training Seminar or similar Industrial Security training events (Industrial Security includes areas such as Industrial Security Management, Information Security, etc.) [Fees vary]
- CDSE / STEPP Courses [Free]
- IOSS OPSEC [Free]
- Company security-related courses [Free]
- Committee work at local or national levels [Free]
- NCMS National Brown Bags via WebEx (attendee or presenter) [Free]
- Serving as a Mentor for Local Chapter or National level [Free]
- Chapter training [Portion is Free]
- Chapter seminars [Generally reduced fees]]
- Membership/participation in other security organizations [Varied costs]
- Writing Industrial Security articles, example an article for the Bulletin

Notes:

- Presentations must be at least 50 minutes to qualify for the one hour = one CEU

- Business-related courses do not apply towards CEU credit



CEU Highlights



- Updated the ISP_® Certification handbook and other associated documentation to reflect CEU changes
 - Chapter Chairs can issue a maximum of 2 CEUs for Chapter meetings that qualify. There must be a training presentation that is an Industrial Security related topic presentation that lasts at least 50 minutes
- Communicated CEU information
 - Wrote articles for the Bulletin
 - Posted information on the ISP® website
- Recommendation send any training / documentation that needs CEU determination to get CEU award review at the earliest possible date...do not wait until recertification is under way



Exam Prep Program



- This voluntary program is related to, but separate from, the ISP_® Certification Program.
- It is an informal program, run by ISPs® that is designed as a method to assist candidates in preparation for the ISP® Certification Examination.
- This program does not provide "answers" to the ISP_® examination questions. Rather, it provides a structured approach to studying, a platform for discussions that will assist the candidate in confirming the accuracy of their knowledge, and a refresher on test taking strategies.




Exam Prep Program



- Workbooks were reviewed and updated in Jan 2014
- CDs with workbook are available for purchase at the NCMS seminar store for the first time (2014)
- Extension of the EPP to the local Chapter Study Groups
 - Managed and operated by the Chapter
 - Use the EPP workbook as a resource
 - Attendees register to obtain EPP workbook
 - Created documentation to assist the Chapters in establishing and conducting the study groups







Recertification Notes



- Know your recertification date and ensure your application is submitted in a timely manner
- Ensure Recertification applications are complete and contain all support materials as required
 - Include all applicable certificates and records. MMCo cannot perform the research/contact agencies to obtain certificates and records on your behalf
 - List all attached certificates on the application
- Online recertification application system in work
 - Will be able to upload certificates and support material as they come available
 - 3 year recertification cycle will remain in place



Recertification Notes




- The level of effort for recertification should be practical to obtain with or without company budgets
