1. Is there reciprocity between ASIS and NCMS for recertification CEU's?

Yes you will be notified. Per NCMS reminder letters go out via USPS 6 months, 3 months and then by email 1 month prior to the recertification month.

3. Is it possible to review what has been entered in the ISP Recert to prevent redundant entries?

4. If I passed the ISP exam at the Annual Training Seminar, can the CEU's earned at that Annual Training Seminar be counted towards recertification? If the seminar was after the exam Yes.

5. I have been the chapter nomination chair for the past few years. What documentation proof is required to get CEU credit?

You will need documentation from your chair (email or letter) and you submit that letter or email etc.

6. I attended Defense Institute of Security Assistant Management International Programs Security Class Room Training (3-Days) Foreign Military Sales requirement. 20 CLPs. Can I submit this for ISP Recertification Consideration?

Submit it with the ISP CEU requirements and if it meet the prerequisites yes.

7. How soon after submitting documentation will we know if credit is received?

Within 5 business days

8. How do we prove we went to an Infragard meeting? Anything beyond the agenda?

You will need the attendance record

9. For instance, we might have an agenda, but the FBI/Dept of Commerce doesn't send certificates or copies of the sign-in logs

You MUST have an agenda and attendance certificate. If they will not furnish it you cannot receive credit.

10. I have been officer all three years since my last recert. What do I use for documentation? How does one prove voluntary service at National?

National will give you the schedule for the volunteers use it. Seminar volunteers have received certificates over the last few years. Have the chapter chair give you an email or letter proving it.

11. I passed ISP on Monday of last year's Seminar. Rcvd the 24 CEUs Cert of Training for attending full Seminar-after passing test. Cert of Training and Award of ISP are only dated as the month, 'June 2016'. Those 24 count towards current recert accumulate?

Yes you still will receive credit.

12. What is the ICW new mentor program? Does the mentoring for CEUs have to part of a formal mentor program?

NCMS mentoring CEUs are covered in the Recertification guide and you will get credit as long as it is an NCMS mentoring program, as in a formal mentoring relationship.

13. What if we submit, say 75 CEUs, but only 55 are accepted. Can we then take actions (classes etc.) to make up the missing CEUs before our time limit is up?

Yes, although they must be completed before the end of your recertification cycle.

14. We must take the one hour CDSE PII training annually. Can you get CEU for each year?

Yes strip off the details of the course and submit that in the on line application.
